The Promotion begins August 8, 2017 at 8:00:00 AM Eastern Time (“ET”) and ends at 5:00 PM ET on October 6, 2017, (“**Promotion Period**”). The Promotion consists of one winner each week and a final Grand Prize Winner. Weekly Winners will be randomly selected from entries received online the previous week. Weekly drawings will be held on the following dates: August 14, August 21, August 28, September 5, September 11, September 18, September 25, October 2, 2017. Weekly winners will win a Griller’s Giftpack to include a set of grill tools, apron, & cutting board. The Grand Prize winner will be randomly selected from ALL entries received through 3:00pm October 6, 2017. All winners must be a York County Natural Gas Authority(YCNGA). The grand prize AOG Grill includes cart package with sideburner. Installation is NOT included, but can be arranged for SALE price to include \$60 off ‘new’ installation (piping and connection). Grill must be picked up at YCNGA showroom by winner. Delivery is NOT included.
