PURPOSE

The purpose of the Energy Conservation Program (ECP) is to provide assistance and incentives for residential homeowners in our service territory to switch from another energy source to natural gas appliances which offer energy savings and reliability.

ENERGY SAVINGS WITH NATURAL GAS

The following table illustrates the comparative savings when using natural gas for space heating, water heating, cooking and clothes drying instead of other energy sources. The figures below are calculated based on a home having an annual use of 50 million BTU's of energy. A BTU is a common denominator used to compare various energy sources. Results may vary depending on your actual rate, the efficiency of the equipment used and other factors.

Natural Gas	\$715	N/A
Electricity	\$2,277	\$1,562
Propane	\$2,495	\$1,780
Fuel Oil	\$1,855	\$1,140

*Energy calculation based on Electricity at \$0.1295 per KWH, Propane at \$3.78 per gallon, Oil at \$4.62 per gallon and Natural Gas at \$1.17 per therm

APPLIANCE REBATE SCHEDULE

Homeowners who switch to natural gas from another energy source by installing new natural gas appliances or converting qualified appliances, are eligible for Conversion Rebates.

Water Heater	\$ 400.00
Dryer	\$ 75.00
Range	\$ 50.00
Maximum Rebate per Service Address	\$925.00

PROGRAM GUIDELINES

- YCNGA will provide rebates (see schedule above) to customers when program conditions are met. Rebates will be credited against balances on any current or previous account. Credits will be applied to the customer's account only and not to a subcontractor account.
- Customers may purchase appliances from YCNGA or another appliance dealer. Appliances purchased from and installed by YCNGA, will have rebate applied against the purchase price. Customers purchasing appliances from another dealer must fill out a Rebate Request, provide a copy of the sales receipt and have installation of the appliance verified by a YCNGA employee. Appliances converted from another energy source to burn natural gas must be converted by a licensed HVAC contractor.
- YCNGA has the sole right to determine if an appliance qualifies for rebates under the ECP Program. Some appliances such as hybrid heating systems and gas logs do not qualify. If you have a question about an appliance, please contact Sandra King at 803-323-5422.

PROGRAM CONDITIONS

(to receive a rebate all conditions must be met)

- Customer will complete a separate Rebate Request Form for each individual dwelling.
- If the appliance is not purchased from YCNGA, the customer must provide a copy of the original appliance purchase receipt or receipt from a licensed HVAC contractor if the appliance has been converted from another energy source. Rebate request form must be submitted within thirty (30) days from the date on the purchase receipt.
- Conversion of appliances must be verified by a YCNGA representative. Customer will provide access to the dwelling for verification of installation. YCNGA must be able to verify installation of appliance within thirty (30) days of receipt of rebate form.
- YCNGA will provide one rebate per appliance type — i.e. if two (2) water heaters are installed; only one (1) rebate will apply.
